Sub:- Security Arrangement in connection with Republic Day 2019

Sir,

As you are aware that **Republic Day 2019** would be celebrated like every year. On this occasion Parade & VVIPs/VIPs pass through BSZ Marg & Mahatma Gandhi Marg, Ring Road, Delhi.

In view of the intelligence inputs, present threat perceptions the high rise buildings along the route can be used by any militant organization and miscreants during the visit of Parade, VVIPs & VIPs. These high-rise buildings are very vulnerable and need full proof security.

I therefore suggest you to take necessary action on the following points to avert any incident:-

- The officer-in-charge of the building must ensure that the building is not free for entry to any unidentified person/persons. All rooms and windows are properly locked/closed.
- It must be ensured that no unidentified object is there in the building and in the premises.
- Admn. Officer/Security Officer will ensure that the building is not used for any nefarious activity.
- Only identified vehicles are parked behind the building and in no case along the route side.
- The Office-in-Charge/Security Officer of the building will be responsible for keeping the building free from unidentified object/person/unidentified vehicle.
- The keys of the building should be available with the night guard/watchman before the day of visit of VVIP for arrangements to be made on rooftops.
- Kindly arrange to supply the list of vehicles generally parked in the premises during the night with a certificate that the same have been got checked.
- The Security Officer will ensure that the AC unit is checked from technician and no explosive substance is fixed in it and give a verification certificate in this regard.
- All the security-in-charges of buildings/Installations on VVIP route are requested to maintain maximum vigil in their respective establishment.
- They are requested to brief their own staff regularly in order to maintain maximum vigil in their respective buildings.
- You are also requested to inform the police about any suspicious thing/object/person if it comes to your notice.
- Renovation/construction/digging work should be stopped immediately.
- The sealing & checking process of the offices/Buildings will be conducted by Police from 1 PM onwards on 22.01.2019 and on 25.01.2019. The De-sealing will be done on next day after completion of Parade Programme on 23.01.2019 and 26.01.2019.
