

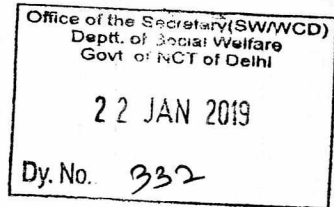
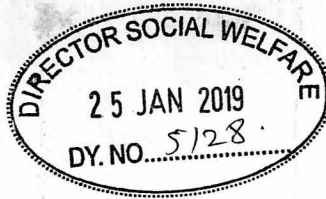

21. Care, Protection and Welfare Schemes for Senior Citizens.
