Special CEO informed the chair that the office of the Chief Electoral Officer, Delhi, is committed to Accessible Elections for Persons with Disabilities (PwDs). It was also informed that during the last election process ALIMCO had very graciously provided wheel chairs free of cost to this office, to facilitate the Persons with Disability to exercise their franchise in Parliamentary/Legislative elections in Delhi.

Special CEO Delhi also suggested the chair that the services of Volunteers from University of Delhi, Directorate of NCC, Directorate of Education and GGSIP University could be utilized for safe and smooth handling of wheel chairs and facilitating the PwDs during the poll for the current General Elections.

The aforesaid agenda was discussed with all the present representatives. During the discussion the representative of ALIMCO informed that they are unable to provide wheelchairs free of cost for the General Election 2019 and the CEO Delhi has to purchase the wheelchairs as discussed during the ECI meeting. After discussion it was decided that CEO shall make its own arrangements of from next election onwards by purchasing the wheelchairs after taking the proper approval from the Competent Authority, but due to lack of time in General Election-2019, ALIMCO shall provide 3000 wheelchairs free of cost to the Office of CEO, Delhi, for the Lok Sabha General Election as its commitment to smooth and Accessible General Election -2019 in Delhi. However, this shall be one time measure.

During the meeting it was also decided that a letter shell be sent to the Ms. Shakuntala D. Gamlin, Secretary, Department of Empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, 5Th Floor, Paryavaran Bhawan, CGO Complex, Lodhi Road New Delhi with the request to issue necessary directions to the ALIMCO for providing 3000 Wheel Chairs for upcoming Lok Sabha Election 2019.

Chief Electoral Officer, Delhi also directed the Directorate of Education and Department of Social Welfare for moving a proposal for procurement of enough number of wheel chairs to be used for their own use in their institutions and for their deployment in future elections in Delhi.

Further, It was also decided that Directorate of Education shall provide a list comprising of two students of class–XII (session 2019-20) from each of its schools, GGSIP University shall provide a list of 1200 students, University of Delhi 1200 Students and NCC 6000 cadets (Junior Wing) by 28th February, 2019, for utilizing their services as Volunteers in General Elections 2019. It shall also be ensured by the aforesaid institutions that the list be so comprised that it consists of 50% male & 50% female volunteers as far as possible.

It was also decided that IPH, DDUNIPPD, will procure the wheelchairs from ALIMCO and shall provide the training to the Volunteers to sensitize them for safe and proper use of wheelchairs and facilitating the persons with disabilities in casting their votes in General Election – 2019.
