**Sub : A/A & E/S of Rs.23,04,487/-(Rs. Twenty Three Lakh Four Thousand Four Hundred Eighty Seven) for Civil Miscellaneous repair works in Old Age Home at Bindapur, Delhi.**

Sir,

I am directed to convey the administrative approval and expenditure sanction of the Competent Authority, Department of Social Welfare, GNCT of Delhi for **Rs.23,04,487/-(Rs. Twenty Three Lakh Four Thousand Four Hundred Eighty Seven)** for Civil Miscellaneous repair works in Old Age Home at Bindapur, Delhi, subject to compliance of codal formalities, GFR, 2017.

The following scope has been taken in the estimate:-

1. In order to repair the leakage in sewer line, dismantling & rejoining of sand cast Iron (SCI) Pipes have been considered including replacing of unserviceable and eroded pipes with the new pipes & their accessories such as bends, tees etc. with lead caulked joints.
2. Repair to damaged false ceiling by providing & fixing galvanized perforated false ceiling in toilet & kitchen and common areas.
3. Plastering the passage walls where earlier the plaster has fallen dangerously.
4. Distempering of the rooms, toilets and kitchen including old work as well as new work.
5. Providing the cement concrete over the kachcha porting along the boundary wall in order to prevent the rats & mice making big holes along the boundary wall and weakening the same.
6. New kerb stones have been considered along the boundary wall after dismantling old broken kerb stone in order to strengthen the boundary wall.
7. Miscellaneous sanitary works such as WC, Cistern, PVC connections, bib cocks, angle valves, bottle traps and PVC waste pipes etc. have been considered.
