- 2.The funds are voted by Delhi Legislative Assembly for the financial year 2019-20.
- 3.The expenditure to be met within the sanctioned budget for the financial year 2019-20.
- 4.The purpose for the posts were created still exists.
- 5.The administrative department shall ensure that all the above posts shall be got converted into permanent as per rules, if these temporary posts are more than three year.
- 6.The administrative department shall ensure that posts abolished subsequent to its creation have not been included in this proposal.


