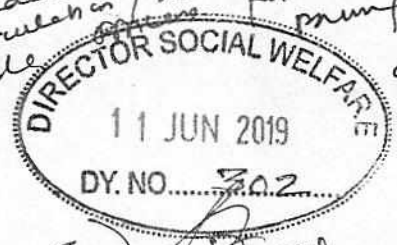
This has reference to order dated 18.04.2019 of the Court of State Commissioner for Persons with Disabilities, NCT of Delhi in Case no. 275/1121/2018/05/1905 and subsequent direction from the worthy Chief Secretary vide U.O. No. CS/2019/9959-9962 dated 25.04.2019 wherein the honorable court has highlighted and urgent need for sanitizing the officer and other functionaries at all level for giving due importance to the issues concerning person with disability. Chief Secretary has directed the provision of the Rights of Persons with Disabilities Act, 2016 & rules made there under should be implemented scrupulously.

The Directorate of Training has proposed a training programme to impart training on the Rights of Persons with Disabilities Act, 2016 on 05.07.2019, from 9:30am to 4:30pm at Directorate of Training, UTCS.
