Minutes of the meeting held in the Conference Hall of Principal Accounts Office on 10.10.2019 at 03:30 P.M. with the representatives of Administrative Departments to ascertain the status of pending cases of revision of pension/family pension w.e.f. 01.01.2016.

List of the officers who attended the meeting is attached as **Annexure-I**.

2. The meeting was convened to ascertain the status of outstanding cases of revision of pension/family pension of pre-2016 pensioners/family pensioners with the departments where such cases are pending as per instructions issued by the Office of Controller General of Accounts, Ministry of Finance in the meeting held in their Office on 26.09.2019. The Office of CGA has advised to settle the outstanding revision of pension cases in a time bound manner so that benefit of revision of pension could be given to all pensioners/family pensioners who are eligible for revision as on 01.01.2016.

3. The status of outstanding cases was reviewed with the representatives of the concerned Administrative Departments who were present in the meeting. Representatives submitted that most of the cases are outstanding at the level of their subordinate offices. Also that in most of the cases either details of retirees or the service records are not available with their departments and as such it would not be possible to take up the revision of pension cases. Some of the representatives submitted that details of retirees required for notional fixation of pay from time to time, fixation of pension w.e.f. 01.01.2016 are available and under process and cases would be submitted to PAO concerned shortly.

4. After detailed discussion, it was decided and advised as under:-

- (i) Departments where records and other details are available would process and finalize the cases and submit the complete cases to PAO concerned for issuing the revised authority of revision of pension in next 15 days period.

- (ii) Departments would convene the meetings at their level with their subordinate offices and advise them to take up the remaining revision cases in a time bound manner.
- (iii) Where records and other details required for fixation of pay from time to time and fixation of pension/family pension w.e.f 01.01.2016 are not available, list of such pensioners may be obtained from the concerned PAOs for processing and finalization of revision of pension cases.
- (iv) PAO concerned would provide appropriate support to the departments in providing the details of retirees alongwith other details such pay scale held, pay drawn and post held at the time of retirement.

5. It was also decided that next review meeting would be fixed in the 2nd week of December, 2019. The date, time which would be intimated to all concerned separately.
