The manufacturer / dealer will sell E-rickshaws for registration in Delhi only to those persons who are in possession of an effective Learners' Driving License to drive an E-rickshaw issued by the Transport Department after obtaining a trade certificate in Form-17 as per the provisions of rule 35 of CMVR from the Transport Department. This approval is further subject to opening of dealership and sale through authorised dealers only.

All MLOs / MLO (HQ)/CMVI / ARU (Burari) are requested to accept the Base model **RUNNER** manufactured by M/s Creative Engineering, in NCT of Delhi subject to fulfilment of provisions of Motor Vehicle Act, 1988 and rules made there under and the department's instructions/order issued from time to time in this regard.
