




**NOTIFICATION**

Whereas, the Central Motor Vehicles Rules, 1989 were amended by the Ministry of Road Transport and Highways, Government of India vide notification numbers GSR 290 (E) dated 15<sup>th</sup> April, 2015 and GSR 424 (E) dated 01<sup>st</sup> May, 2017 mandating fitment of speed governor in certain categories of transport vehicle.

Whereas, the Ministry of Road Transport and Highways, Government of India further issued guidelines on 21<sup>st</sup> December, 2017 in the matter of WPC (L) No. 1408 of 2017 in Mumbai Taxmen's Union and Others Vs. Union of India before Hon'ble Bombay High Court –that " the provision of section 110 (3) (b) of the Motor Vehicle Act, 1988 which empowers the State Government to exempt any motor vehicle or any class or description of the motor vehicles from the rules made under sub-section (1) of section-110 of the said Act, States may take recourse to the above mention provisions to exempt specific modals of the motor vehicles from the requirement of fitment of speed governors till the time the speed governors of at least two or three manufacturers are available at the competitive rates, for fitment by the transport vehicle owners".

Now, therefore, in exercise of the powers conferred by clause (b) sub-section (3) of section-110, of Motor Vehicle Act, 1988, the models of vehicles mentioned in annexure of this notification are hereby exempted from the requirement of fitment of speed governor, under Rule-118 of Central Motor Vehicles Rules, 1989 for a period of six months or till the time, the concerned speed governors of at least two or three manufacturers are available in the market for these vehicles for fitment by the transport vehicle owners, whichever is earlier.


This notification is issued with the approval of Hon'ble Minister (Transport), Govt of NCT of Delhi.
