Conclusion of Test Report of RICHLOOK E-Rickshaw:- Maximum 30 minutes speed 17.75 KM/HR; Net Power 1.275 kW & Maximum 30 minutes power 1.196 kw. It has been certified by the testing agency that the vehicle meets the requirements as per Notification G.S.R. 709(E) and the tests were conducted as per the requirements of AIS-041: 2003, S.O. 2590(E) dated 08.10.2014 at ICAT, Gurgaon. dated 08.1.2014.								

The approval is accorded subject to the responsibility of the manufacturer / Importer for ensuring the fitment of the same component, parts/ assemblies etc details of which are given in detailed specifications approved by ARAI, Pune.

The manufacturer / dealer will sale E-rickshaws for registration in Delhi only to those persons who are in possession of an effective Learners' Driving License to drive an E-Card issued by the Transport Department after obtaining a trade certificate in Form-17 as per the provisions of rule 35 of CMVR from the Transport Department. This approval is further subject to opening of dealership and sale through authorised dealers only. The manufacturer should also ensure compliance of Ministry of Road Transport & Highways, Govt. of India Notification No. G.S.R.No. 749 dated 07.08.2018 that **"2A In case of Battery Operated vehicles, the registration mark shall be exhibited in Yellow colour on Green background for transport vehicles.**

All MLOs / MLO (HQ)/CMVI / ARU (Burari) are requested to accept the Base model **RICHLOOK** manufactured by M/s Bright Metal Works, in NCT of Delhi subject to fulfilment of provisions of Motor Vehicle Act, 1988 and rules made there under and the department's instructions/order issued from time to time in this regard.
