

The manufacturer / dealer will sale E-rickshaws for registration in Delhi only to those persons who are in possession of an effective Learners' Driving License to drive an E-rickshaw issued by the Transport Department after obtaining a trade certificate in Form-17 as per the provisions of rule 35 of CMVR from the Transport Department. This approval is further subject to opening of dealership and sale through authorised dealers only.

The manufacturer should also ensure compliance of Ministry of Road Transport & Highways, Govt. of India Notification No. G.S.R.No. 749 dated 07.08.2018 that **"2A In case of Battery Operated vehicles, the registration mark shall be exhibited in Yellow colour on Green background for transport vehicles"**


