Sir/ Madam,

As this is the well known fact that the 7th CPC arrears in r/o faculty yet to be drawn due to non-live of portal. For making the portal live for preparing the 7th CPC arrears of the faculty, last request to Controller of Accounts, Principal Accounts Office was forwarded vide letter No. DTTE/AC/1(1)/(Budget)/2020-21/7382-88 dated 22.07.2020, in the clear cases except points of observation from 1 to 7 (copy enclosed).

Our request was considered and deliberated in Principal Accounts Office on 23.07.2020. DCA (Admn.), Pr. AO told to the undersigned that the observations were noticed from the bill taken randomly for checking during testing on staging server and there may be possibility of more such cases and as such there is need of extensive checking and to take utmost care for entering data of drawn and due salary, in case the editable mode is made live. After discussion, it revealed that for drawl of arrear in the cases as per the observation of Pr. AO, the editable mode is required. Hence, request is required to be submitted after seeking approval of Secretary, TTE. Therefore, asked to the department for sending the request duly approved by the Secretary, TTE for having the portal live in r/o all the faculty with keeping editable mode also.

In view of above, it is requested that the proposal may be sent to this office by 4.00 PM today positively with details of observations pointed out by Pr. AO showing details of the relevant cases. A copy of the PAO observation is enclosed for your ready reference. An undertaking and assurance may be submitted to the effect that the due care will be taken while preparing the arrear bills with checking carefully by AAO/ AO/ DDO, HOO and Principal.

Testing of 7th CPC arrears of Faculty under DTTE on staging Server-Live of Portal for preparing 7th CPC Arrear

Sir,

With reference to your office mail dated 20.07.20 in the matter relates to testing of provision of 7th CPC arrears of Faculty of 12 Institutes under DTTE on staging server. It is worth mentioning that your good office has resolved most of the problems being faced by the DDO's in preparation of 7th CPC arrear and 11 observations detailed as below given in this regard has been noted.

- 1. The manual salary arrears/DA arrears bills have been prepared by department, as these are manual they are not covered under the data transferred from 6th CPC to 7th CPC.
- 2. Existence of multiple IDs of same person, one is used in previous department and New ID has been created in current department. It was observed multiple IDs even exist in same DDO and they are in use for salary as well as arrears.
- 3. The department has created new IDs of employee in 7th CPC instead of transferring old ID from 6th CPC e.g. AIACTR.
- 4. The erroneous amount entered in drawn amount for drawing salary arrears in 6th CPC system being editable.
- 5. Salary arrears are drawn through Miscellaneous Receipts instead of arrear bills.
- 6. Erroneous NILL bill preparation upon transfer i.e. the net amount of bill made zero by miscellaneous recovery field.
- 7. Arrear bill prepared in salary arrears instead of 7th CPC salary arrears on staging
- 8. Employee drawn HRA through salary arrears even having a Govt. Accommodation.
- 9. Excess HRA & TPT amount drawn by employees though salary arrears.
- 10. Jaffarpur Engineering College already paid 7th CPC arrears to their lecturer through salary arrears.
- 11. The arrears of employees who are on deputation can be prepared by issuing their LPC under "Deputation".

The above noted observations will be taken up separately after discussion with higher authorities. In the meanwhile it is requested that Portal may be LIVED for preparing 7th CPC arrears of the staff which are clear except under points from 1 to 7 of your observations.

SUB: TESTING OF 7CPC ARREAR OF LECTURERS OF DTTE

The matter on file relates to testing of provision of 7cpc salary arrears of lectures of DTTE on staging server. The PAO (HQ) had shared a link to DTTE of staging server for testing the salary arrears of their employees. Several mails received from them about erroneous/wrong calculation of the drawn amount of employees. Meanwhile a letter dt 26/06/2020 was also received on 01/07/2020 from Association of Gazetted Officers Technical Education (AGOTE), Delhi alleging that their salary arrears are not disbursed due to lack of co-ordination among the officials of PAO & NIC.

Subsequently, Sh. S.N. Mallick and Sh. S.M. Parashar had visited this office for the knowing the delay of their arrear. The Joint Director (IT) clarified our software is ready and needed an User Acceptance Certificate (UAT) from User Department before make it available on live server. Sh. Mallick, AGOTE President was satisfied & wrote their remarks which are reiterated here as " Consequent upon our discussion with officials of Principal Accounts Office & subsequent talk regarding to resolve the issue at earliest with verbal assurance, we understand the issue appropriately".

DCA (Pension) also telephonically contacted with DCA, DTTE to send their DDOs at PAO (HQ) for showing the issues that they are facing while preparing 7cpc salary arrears of lecturers of their institutions. The date-wise details of the facts & observation made are as under:
