CIRCULAR

Subject : Preventive measures to contain the spread of COVID-19 in N.C.T. of Delhi.

This is in continuation of this office Circular/Office Order F.No. 24(2013)/DJB/AC(W)/2020/e-receipt No. 964402 dated 17.04.2020, vide which Order No. F/02/2020/S.I/53 dated 15.04.2020 issued by Chief Secretary, GNCT of Delhi, along with its enclosures (Consolidated Revised Guidelines), regarding extension of lockdown period in Delhi beyond 14th April, 2020 up to 3<sup>rd</sup> May, 2020 was circulated.

In this regard, another Order No.f.2/07/2020/S.I/64 dated: 19.04.2020 has been issued by Chief Secretary Delhi, DDMA, vide which it has been directed to all the Departments of GNCT of Delhi to maintain "status-quo" with respect to strict implementation of revised consolidated guidelines enclosed in the Order dated 15.04.2020, without any relaxation for additional activities till another comprehensive assessment on 27<sup>th</sup> April, 2020 or further orders, whichever is earlier.

The above orders dated 19.04.2020 are enclosed for strict compliance.

ORDER

Whereas in exercise of the powers conferred under Section 22 of the Disaster Management Act, 2005, the undersigned in his capacity as Chairperson, State Executive Committee, has issued an Order dated 14<sup>th</sup> April, 2020 that in view of the extension of lockdown period by Government of India, all such orders whose validity was only till midnight of 14<sup>th</sup> April, 2020, shall remain valid till midnight of 3<sup>rd</sup> May, 2020 or until further orders whichever is earlier;

And whereas vide Order dated 15.04.2020, the undersigned issued directions to all the departments of GNCT of Delhi for strict implementation of the consolidated revised guidelines issued by MHA, Govt. of India vide order No. 40-3/2020 DM-II(A) dated 15.04.2020 which *inter alia* incorporated select additional activities as relaxations w.e.f 20<sup>th</sup> April, 2020 with the caveat that UT Government may impose stricter measures as per requirement of the local areas.

And whereas, the situation of COVID-19 in Delhi has been assessed, and in view of the present scenario, it appears to be necessary to maintain status quo in larger public interest.

Now Therefore, in exercise of the powers conferred under Section 22 of the Disaster Management Act, 2005, the undersigned in his capacity as Chairperson, State Executive Committee, GNCT of Delhi, hereby issues directions to all the Departments of GNCT of Delhi to maintain "status-quo" with respect to strict implementation of consolidated guidelines enclosed in the order dated 15.04.2020 without any relaxation for additional activities, till another comprehensive assessment on 27<sup>th</sup> April, 2020 or further orders, whichever is earlier.
