Subject:- "Departmental Examination in "Simple Accounts" for JEs(Civil)/JEs(E&M) scheduled to be held on 20<sup>th</sup> April, 2020 through CPWD.

This office vide Circular No. F.No. 07(2019)DJB/AC(T)/JE(C)/JE(E&M)/Exam-Simple Acctt./12084 to 12259 dated 28.02.2020 directed to all JE's of Delhi Jal Board to deposit DD amounting of Rs. 2000/- each in favour of AAO (Cash), CPWD Training Institute, Ghaziabad towards the fee of aforementioned examination.
