The aforesaid office order provides for benefits of notional appointment, notional pay fixation, notional seniority, Old Pension Scheme and transfer of NPS contribution to GPF to the above 17 employees.

In continuation to office order no. 97 (min.) dt: 27.05.2020 a Provisional Revised Seniority List in respect of Jr. Assistants appointed in DJB on regular basis w.e.f. 01/05/2003 to 31/12/2007 was circulated on 07.07.2020 calling objections from the affected officials.

As per directions of Hon'ble CAT in OA no. 3578/2016 aforementioned 17 employees are placed below Sh. Bashisth Kumar at Seniority no. 492, i.e. the last UR category candidate of the same recruitment and above Ms. Archana Pant. The objections received this regard have been duly considered and it is, hereby, informed that no objections have been received in respect of the revised seniority resulting from the placement of above seventeen officials. As regard to objections related to any change in the old seniority it is, hereby, informed that the Final Seniority List of LDCs was issued on 30.06.2009 after providing enough time and opportunity. Any claim, at this stage, from officials who failed to submit objections before issuing final seniority list on 30.06.2009 for change in respect of the position and particulars in the old seniority list other than resulting from the revised placement of the above seventeen officials are not found justified. There representations are accordingly disposed off.
