Sub: Observance of 'Vigilance Awareness Week, 2020'

The observance of the week will commence with the **Integrity Pledge** (copy enclose). The pledge is to be administered to all employees and staff of Delhi Jal Board at 11:00 AM on 27.10.2020. Staff working at Varunalaya Complex may assemble at the open space between Varunalaya Phase-I and Phase-II at 10:50 AM on 27.10.2020 for taking the pledge at 11:00 AM. Employees may take e-pledge by visiting the website. Those who take the pledge orally are advised to record it through website. The pledge is also to be administered to the members of the staff working outside Varunalaya Complex, by the respective senior most officers sitting in that complex i.e. CE/SE/EE/Jt.Dir(Rcv.)/Dy.DOR/ ZRO/ZEs, etc, at the aforesaid date and time. The online "Integrity Pledge" is available on the CVC's website <http://www.cvc.gov.in>.

Further, all Maintenance Zones should organize meetings on digital platform with RWAs of their respective areas wherein the EE concerned, as Nodal Officer and ZROs, may explain the grievance redressal mechanism to them and receive grievances of RWA/their members.

All the Nodal Officers should depute a responsible subordinate official to collect Banners and Posters from Vigilance Branch between 19.10.2020 to 23.10.2020. These Banners/Posters are required to be displayed on the main gate of the building and should be visible to general public.

All Covid-19 SOP and protocols be followed while administering Integrity Pledge.

A compliance report on the VAW-2020 may be furnished to the Vigilance Department latest by 15.11.2020.
