
Sub: Closure of all the Schools (For Heads of Schools, Teaching & Non-Teaching Staff & Students) and Postponement of Annual Examination & Board Examination

In view of the spread of Noval Corona Virus (COVID-19) and for taking precautionary measures, all the Heads of Govt., Govt. Aided, Unaided Private Recognized Schools of Directorate of Education, and Local Bodies i.e. MCDs, NDMC & Delhi Cantonment Board of Delhi are hereby informed that all the above said Schools will remain closed for all the Students, Heads of Schools, Teaching & Non-Teaching Staff from 19.03.2020 to 31.03.2020 (Both days inclusive). The ongoing Annual Examinations are also postponed from 19.03.2020 to 31.03.2020. However, Evaluation work of Annual Exams are to be carried out by the concerned teachers from their home.

Further, it is also informed that the Revised Schedule for conducting the Common Annual School Examination for Govt. and Participating Govt. Aided Schools in District North-East & District East also stands postponed till 31.03.2020.

As per the Press Release issued by CBSE (Enclosed) on 18.03.2020, CBSE has postponed ongoing Board Examinations scheduled from 19.03.2020 to 31.03.2020 (both dates inclusive) for Classes X & XII. These Exams will be rescheduled after 31.03.2020. CBSE has further informed that the re-examinations rescheduled for North-East Delhi, will also be further rescheduled. Evaluation work of CBSE Exams is also postponed till 31.03.2020.

In this regard, all the Heads of Govt., Govt. Aided, Unaided Private Recognized Schools of Directorate of Education, and Local Bodies i.e. MCDs, NDMC & Delhi Cantonment Board of Delhi are hereby directed to disseminate this information among the Teaching, Non-Teaching Staff, Students and Parents through SMC/Mass SMS facility/Phone Calls etc. Further, all Heads of schools and staff must be available on phone and remain connected with each other and students through electronic media. Also, they should remain at home and not leave station without prior permission and be available for duty at any time, if required.



As a precautionary measure and in compliance of the instructions received from Secretary, Department of Higher Education/ School Education and Literacy, Government of India vide letter No. Secy (HE)/MHRD/2020 dated 18th March, 2020, it has been decided as follows:

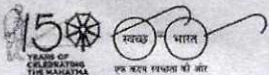
1. All ongoing examinations of the board for classes-X and XII, being held in examination centres in India and abroad, and scheduled between 19.03.2020 to 31.03.2020 (both dates inclusive), shall be rescheduled after 31st March, 2020.
2. During the aforementioned period, re-examinations that were rescheduled to be held for North-East Delhi candidates will also be further rescheduled.
3. All schools may ensure that this information is disseminated to all concerned students from their respective schools.
4. Rescheduled dates will be communicated by the board to all its stakeholders by 31.03.2020 after re-assessment of the situation.
5. All ongoing board exams related evaluation work in various evaluation centres in the country is also suspended upto 31st March, 2020. All Centre Nodal Supervisors may ensure rescheduling of evaluation work from 01.04.2020, unless otherwise informed by the Board.



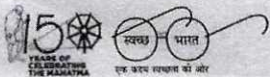
