And Whereas, **Ms. Upasna** did not report in person on the scheduled date and time as given in the offer of appointment issued to her vide letter no. dated 25-11-2019, second offer of appointment issued to her dated 09-01-2020 and Final Reminder dated 11-03-2020 and neither has intimated any reason to the Directorate for not reporting and has not accepted the offer of appointment.

As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally."
