CIRCULAR

Sub: Revised norms for providing Grant In Aid to Delhi State Level Associations for promotion of Sports in NCT of Delhi & also promotion of Sports amongst differently abled sports players of Delhi

With an aim to encourage sports at every level and specifically with regard to promoting sports organized by the Sports Federations/ Associations, Sports Branch, GNCT of Delhi provides financial support by way of Grant in Aid for various purposes to the eligible State Sports Associations/stake holders.

The norms for release of Grant in Aid were initially notified/ circulated in the year 2005 , however, due to changing times and keeping with the modern day requirements, the norms have been updated and modified to cater to the needs of present day.

The norms for release of the Grant In Aid is attached herewith for information of all concerned. These norms shall come into effect from the date of notification/ circulation. These norms will be applied for release of the grant from the year 2019-20.

The applications for release of Grant in Aid will be invited in due course of time.

This is for information of all concerned.

The scheme is issued with prior approval of Finance Department, GNCT of Delhi conveyed vide U.O. No. DSV/395 dated 18.03.2020.

**NORMS/ PATTERN REGARDING RELEASE OF GRANT-IN-AID TO DELHI
STATE SPORTS ASSOCIATIONS WORKING FOR PROMOTION OF SPORTS
IN NCT OF DELHI & ALSO PROMOTION OF SPORTS AMONGST
DIFFERENTLY ABLED PLAYERS OF DELHI**

The following norms for releasing of Grant-in-Aid out of the funds allocated to Sports Branch, Directorate of Education is hereby circulated to all the associations concerned. This scheme will cover all the Sports Associations including those, who are promoting sports games amongst the differently abled players which include intellectually disabled players, physically challenged players and deaf & dumb players will also be eligible for grant on the same pattern.

1. Grant-in-aid shall be given only to state sports associations registered under the Societies Act & Indian Trust Act in Delhi and affiliated to National Federation of India of concerned game(NFS), duly registered/recognized by Ministry of Sports & Youth Affairs, Govt. of India. This grant shall be given only to those associations which are promoting sports and games activities in Delhi / organizing and participating in events / competitions outside Delhi but for Delhi's Sports persons only.
2. The office bearers of the State Level Associations must be elected as per Memorandum of Article of the registered society. The date of the election shall be intimated in advance. A list of office bearers of the Associations shall be submitted while applying for grants. Only State Level Associations shall be entitled for such grant.
3. While applying for grant, the associations shall have to furnish the latest audited statement of accounts of Association.
4. The Sports association shall intimate the Directorate before organizing any event/camps. It will be discretion of the Department to depute an officer to observe the events. Non intimation of the events will render the association not eligible for grant.
5. The grant will be released only once in the financial year after conducting of events/camps/championships on actual basis, as per norms/approved rates of the department.

6. The ceiling for release of grants shall be a maximum of Rs. 10.00 lakhs (Rs. Twenty five lakhs) only per annum.
7. Fresh grant shall not be released to any association unless the utilization certificate is submitted by the organization in respect of the earlier grants along with the Audited Statement of Accounts.
8. Annual calendar of activities must be submitted in advance by associations to the Sports Branch.
9. The association to whom grant is to be released shall be required to disclose the other source / institutions / sponsors from which any sort of financial assistance either in the form of grant or in the form of loan has been obtained for the same purpose.
10. The grant shall be utilized by the association for the specific purpose for which it is sanctioned & no diversion shall be allowed under any circumstances.
11. The grantee associations will maintain a register of assets in Form GFR - 40, under GFR 190 (2) wherein all assets of permanent value and machinery and equipment having a life of not less than 5 years, should find place. Relevant extract of this register should be appended to the annual statement of accounts of the organization showing progressive figures (both stores and value). This register shall be checked by audit authorities.
12. The association shall not dispose off, without prior approval of the authority, any asset (s) acquired wholly, or substantially out of the grant by the department.
13. The account of all beneficiaries/applicant associations shall be open for inspection by the department and Directorate of Internal Audit, Govt. of NCT of Delhi or AGCR at any point of time.
14. The associations must try to complete its activities by the end of December of respective year and to submit its application for release of Grant-in-Aid in the month of January.

Purpose for which Grant In Aid will be provisioned

The grant-in-aid will be given for the following purposes:-

- (a) For organizing coaching camps for states and National camp only. If the state association is provided Grant-in-Aid by any authority for National camps, no Grant will be released.
- (b) For incurring expenditure in organizing official State Championship and National Championship. In case of National championship, if grant is provided by National Sports Federation/ or Ministry of Sports & Youth Affairs then no grant will be released. To obtain grant for National championship, State association shall submit a certificate from National body that no Grant-in-Aid is released in this regard.
15. For other items relating to purchase of sports equipments, material. While making purchase, the component of the item/items shall be in the ratio of 75% : 25% I.e. 75 % grant-in-Aid can be provided upto a maximum of Rs.1,00,000/- by the Department.
16. The accounts of Association shall be subject to the Audit of Comptroller & Auditor General of India and Dte. Of Internal Audit of Govt. of Delhi/ Directorate of Education, GNCT. The cost of such audits will be borne by the Associations, if any.
17. The Associations shall maintain all such reports, statements in respect of the expenditure met from grants released under the pattern of assistance, as may be prescribed by the Govt.
18. The Grant for the subsequent years will not ordinarily be sanctioned until conditions laid down under GFR are complied with fully. The association shall exercise all possible economy in the working, especially in respect of expenditure of Govt.
19. The Association shall be bound to submit time to time such reports, statements etc. in respect of expenditure from the grant as might be required by Govt. of Delhi.
20. The Association shall maintain proper accounts for the grants received from Govt. of Delhi, Govt. of India and other sources.




EXTENT OF AID :

1. To meet all expenditure with regards to :-
 - (a) Organizing coaching camps: - Grant-in-Aid upto Rs. 50/- per head per day. Number of coaching camps permissible : 04 per annum
 - (b) Organizing Delhi State Championship: - Grant-in-Aid upto Rs. 350/- per head per day with a maximum ceiling of Rs. 30,000/- per annum.
 - (c) Participation of Delhi teams in National Championship: - Grant-in-Aid upto Rs. 3,500/- per head. Number of teams permissible: 04 per annum.
 - (d) Organization of National Championship in Delhi :-
 - (i) Grant-in-Aid upto Rs. 350/- per head with a maximum ceiling of Rs. 65,000/- for senior championship.
 - (ii) Grant-in-Aid upto Rs. 300/- per head with a maximum ceiling of Rs. 55,000/- for Junior championship.
 - (iii) Grant-in-Aid upto Rs. 250/- per head with a maximum ceiling of Rs. 45,000/- for Sub-Junior championship.
 - (iv) Grant-in-Aid upto Rs. 200/- per head with a maximum ceiling of Rs. 35,000/- for Mini championship.
 - (e) Procuring sports material: - Grant-in-Aid upto Rs. 1,00,000/- per annum.
21. The associations shall apply the Grant-in-Aid in the prescribed format provided by the Directorate.
22. The Sports Associations will submit a detailed proposal giving details of the equipment; justification for its procurement; proof of having mobilized its share (25% contribution)



23. The associations should maintain an exhaustive and diligent record of the age along with proof of age of athletes who have participated in the National championship and other tournaments conducted by it. Each association shall be required to maintain a national register of athletes, which will be a public document.
24. The Sports associations shall compulsorily provided the details of identity of participating athletes such as Aadhar Card/ Passpsort /Voter I Card etc.
