CIRCULAR

SUBJECT: GUIDELINES FOR REGISTRATION OF ELIGIBLE & WILLING STUDENTS OF GOVT. SCHOOLS OF DoE FOR ADMISSION IN CLASS X (2020-21) UNDER NIOS SCHOOL PROJECT.

In continuation of the circular NIOS/P/2020-21/674-677 Dated: 30/07/2020. The following guidelines are issued for strict compliances regarding registration of eligible & willing students of Govt. Schools of DoE for admission in class X under NIOS Project 2020-21:-

- A. Govt. School Students who failed once in class IXth/ Xth are considered eligible for taking Admission in class Xth under NIOS Project of DoE Delhi. This relaxation is given for the session 2020-21 only.
- B. All 96 Nodal Centres/Study Centres 79 Girls &17 Boys as per list enclosed are directed to start **w.e.f. 6th October, 2020** for the session 2020-21. Students registered under NIOS Project shall start attending classes, when regular schools re-open. These students will continue their studies online or by other means of attending classes under the guidance of teachers deputed under NIOS Project similar to the students of regular schools till the regular schools re-open. It will be the responsibility of the HOS of the concerned Study Centres to facilitate proper teaching learning process and safety and security of the students. The coordinators will be shortly engaged to assist concerned HOS of the Study Centres. In case of Boys Study Centres (Evening Shift) the HOS of the School concerned should ensure the deputation of One Vice Principal as a Centre Incharge by the concerned DDE (District). Even if less number of students have taken admission, the number of Study Centres will not be reduced considering the safety and convenience of students in this global pandemic situation.

- C. The HOS of the parent school shall be fully responsible to trace out and contact such students (the students may not be coming to the schools regularly, due to closure of the schools and spread of COVID-19 pandemic) who are eligible and willing to be enrolled in Class X under NIOS Project for the year 2020-21 in order to minimise the dropout rate. The process of enrolment/registration must be completed up to 10th October, 2020.
- D. HOS of NIOS Study Centres should forward their request to concerned DDE District for engagement of Guest teachers in NIOS Study Centre as per requirement. In case the number of students at the NIOS Study Centres are less, these teachers may be utilised in regular schools and vice-versa.

The rest of the content of the above referred circular NIOS/P/2020-21/674-677, Dated: 30/07/2020. will remain same for the compliances without any change.
