Sub.: Regarding Pre-Matric and Post-Matric Scholarship schemes for Minority students for the year 2020-21 (Centrally Sponsored Scheme) on National Scholarship Portal (NSP).

It is observed that total number of applications received under Pre Matric Scholarship and Post Matric Scholarship schemes for Minority students are very low and also verification of the application received is almost nil at the end of institutions.
