SUB: Workshop on Responsible use of Social Media under Samagra Shiksha (2020-21).

Threat through the unknown and anonymous cyber world is a harsh reality now days. Ease of access and unmonitored reach has exposed the children to unscrupulous elements on the net.

02. The Project Approval Board (PAB) 2020-21 of MHRD, Govt. of India for Samagra Shiksha (SS) has approved a sum of Rs. 31.20 lakh for workshop on "Responsible use of Social Media" under sub component Special Projects for Equity the major component – Gender and Equity for the year 2020-21 as per UDISE+ 2018-19:

03. **Objective:**

The workshop on "Responsible use of Social Media" will create awareness about the various kinds of threats on the internet and also ways to secure oneself from these threats. The children will also be sensitized about responsible use of social media.

The details of the activity are as under –

1. **Activity-** Total 52 sessions will be held online for addressing 7.3 Lac students Classes 9 to 12 only of 13 Districts (136 Clusters) in Delhi and 2 hours sessions will be there including Doubts Clearing Session. Students will be mentored on how to be digitally smart and cyber security fundamentals will be discussed on Responsible use of social media.

a. Each speaker will deliver and address one particular session and a moderator (preferably tech savvy DURCC/CURCC or any technical assistant to RP/Mentor) will be there to drive the session smoothly.

b. The online workshop will be conducted in 26 days i.e 02 sessions daily

c. The timings of the sessions are :

Morning Session: 7:30 am – 9:30am

Evening Session: 6:30 pm – 8:30 pm

d. The workshop will commence **tentatively from 23rd Nov to 23rd December** (working days only). The detailed day wise allocation of schools/students will be intimated shortly.

Guidelines for organization of workshops for sensitization about Responsible use of Social Media:-

1. **The workshop will be conducted through Online Mode in all 13 Districts for the 1040 schools.**

2. Online workshop for Responsible use of Social Media will be conducted in 26 days (52 sessions) i.e, 02 sessions daily. **Registration link is mandatory and open** for the all the secondary level students (1040 schools) to join the

workshop. It is available at (<http://samagrashiksha.com>). The Registration link will be closed on 18 Nov. 2020. Further, All detailed information (Dates of workshop, Timings, Meeting Credentials etc. will be shared to students via registered mail id and sms). The dashboard to access the information of the workshop will also be available at same link <http://samagrashiksha.com>

3. **The amount will be released from Samagra Shiksha (HQ)** under Major component Gender & equity – Special Project for Equity at point no. 167.73 directly to the **bank account/cash payment** to individual Resource Person/Mentor quarterly i.e, just after the completion of activity week (Every 06 working days) once confirmation is verified from the Nodal officer through concerned DURCCs. **Payment received undertaking from all RPs/Mentors to be submitted by Nodal officer to Samagra Shiksha (HQ)**
4. The workshop will be conducted on scheduled days for all 1040 schools District wise and each district will have a time slot.
5. All the necessary arrangements are to be made and supervised by all concerned DURCC. Overall coordination & smooth conduct of the activity is to be looked after by the Implementing cum Nodal officer Mr. Pulkit Rathi, CTO/CDAR.
6. The Resource Person will be delivering expert talk on all the assigned topics covering Cyber security and Responsible use of social media .Further, complete sessions will be recorded and remain in possession of Samagra Shiksha for all purpose.
7. The utilization certificates should be submitted within 14 days of completion of the activity by the DURCC for onward submission at Samagra Shiksha (HQ).

8. The Detailed report of the program along with the recorded videos/screenshots / photos compiled by the concerned DURCC should reach SS-HQ within 14 days of the activity.
9. The CRCCs shall obtain a feedback just after the activity on the impact of the workshop from all stakeholders. The DURCCs will compile it for onward submission to SS-HQ.
10. All DURCCs to ensure the maximum registration & participation from all 1040 schools and students must not face any issues before, during or after the activity. In case of any difficulty/issue concerned, Implementing / Nodal Officer Mr. Pulkit Rathi CTO-CDAR may be approached.
