CIRCULAR

SUBJECT: Guidelines/instructions for the admission of the candidates under EWS/DG category for fresh applications against remaining vacant seats at entry level classes (Nursery/Pre-school, KG/Pre-Primary & Class-1) for the session 2020-21.

The Directorate of Education has already conducted two Computerized draw of lots including adjustment round for the admission under EWS/DG Category at the entry level classes for the session 2020-21 in Pvt. Unaided Schools (except minority schools) recognized under DSEAR 1973 & under RTE Act 2009.

Despite inviting online applications against the available seats vide circular dated 21.01.2020 approximately 838 seats are still vacant. Hence, department has decided to call fresh online applications again from the aspirants under EWS/DG Category against these available vacant seats at present. List of schools with available vacancies/seats will be available on departmental website www.edudel.nic.in from 16/11/2020 onwards.
