It is, therefore, requested to take suitable necessary action as requested in the aforesaid communication including filing of FIRs etc. in the matter against the fake universities as mentioned in the letter in respect of Delhi. An Action Taken Report alongwith supporting documents may be furnished in the case for onward submission of the same to UGC accordingly

The University Grants Commission (UGC) has been receiving complaints against the institutions which are not 'University' within the meaning of Section 2(f) of Section 3 of University Grants Commission Act, 1956 but are conferring the degree or using the word 'University' with their names and are defrauding and cheating innocent students by awarding fake/invalid degrees. The UGC has been publishing the list of fake universities (existing/functioning) across the country in the News Papers and is also uploading it on its website: www.ugc.ac.in to warn the students not to take admission in such universities. A copy of the list of such fake universities is enclosed.

You are requested to inform the current status of these and such other unrecognized institutions existing/functioning in your State. You are also requested to take suitable action against them and register an FIR in the police station within the jurisdiction of which, the institute is located. In case, any of these fake Institutions are not existing now, the information with due proof, may be sent to UGC to enable UGC to process the case for removing its name from the list of fake universities maintained by the UGC.

Extracts From the UGC Act, 1956

Section 2(f)

“University” means a University established or incorporated by or under a Central Act, a Provincial Act or a State Act, and includes any such institution as may, in consultation with the University concerned, be recognized by the Commission in accordance with the regulations made in this behalf under this Act,

Section 3

The Central Government may, on the advice of the Commission, declare by notification in the Official Gazette, that any institution for higher education, other than a University, shall be deemed to be a University for the purpose of this Act, any on such a declaration being made, all the provisions of this Act shall apply to such institution as if it were a University with the meaning of clause (f) of section 2.

Section 22

1. The right of conferring or granting degrees shall be exercised only by a University established or incorporated by or under a Central Act, a Provincial Act or a State Act or an institution deemed to be a University under Section 3 or an institution specially empowered by a Act of Parliament o confer or grant degrees.
2. So as provided in sub-section (1), no person or authority shall confer, or grant, or hold himself or itself out as entitled to confer or grant, any degree.
3. For the purpose of this section, “degree” means any such degree as may, with the previous approval of the Central Government, be specified in this behalf by the Commission by notification in the official Gazette.

Section 23

No institution, whether a corporate body or not, other than a University established or incorporated by or under a Central Act, a Provincial Act or a State Act shall be entitled to have the word “University” associated with its name in any manner whatsoever:

Provided that nothing in this Section shall, for a period of two years from the commencement of this Act, apply to an institution which, immediately before such commencement, had the word “University” associated with its name.

Section 24

Whoever contravenes the provisions of Section 22 or Section 23 shall be punishable with fine which may extend to one thousand rupees, and if the person contravening is any association or other body of individuals, every member of such association or other who knowingly or willfully authorizes or permits the contravention shall be punishable with fine which may extend to one thousand rupees.
