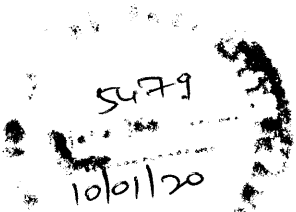

CIRCULAR

The General Elections to Delhi Legislative Assembly - 2020 have been announced and Model Code of Conduct (MCC) has come into force. Accordingly, a Screening Committee has been constituted for examining each proposal related to Model Code of Conduct before sending it to the Chief Electoral Officer, Delhi vide order No. 26 dated 07.01.2020 (copy enclosed). Further, it is requested as follows:-

- (i) All departments of Govt. of NCT of Delhi while forwarding the proposals to the Chief Secretary for consideration/ approval, should clearly mention that provisions of Model Code of Conduct (MCC) are not attracted.
- (ii) The proposals wherein the provisions of MCC are attracted, should be submitted to the above mentioned Screening Committee constituted for examining the proposals related to MCC vide order No. 26 dated 07.01.2020. The proposal(s) cleared by the Screening Committee shall be submitted to the Chief Electoral Officer, NCT of Delhi along with full details and a note on urgency, i.e. why the proposal(s) can't wait till completion of poll/election.
- (iii) Court mandated tasks are to be disposed off in a time bound manner. The proposals which are to be processed in compliance of the directions/orders of a Competent Court/Tribunal, should be submitted for consideration/approval, clearly mentioning the directions of the Competent Court/Tribunal along with a copy of the order.

This issues with the approval of Chief Secretary, Delhi.
