No. 54/(OAH)/Paschim Vihar/EC/ DSW/2012-13/28896-909 dated 09.01.2018 with the permission to place Rs.3,00,00,000/- (Rupees Three Crore only) at the disposal of PWD as 1st installment and Rs.3,00,00,000/- (Rupees Three Crore only) letter no. F. No. 54/(OAH)/Paschim Vihar/EC/DSW/2012-13/45025-39 dated 28.03.2019 as 2nd installment for carrying out the above said work.

Now, Rs. 3,87,84,600/- (Rupees Three Crore Eighty Seven Lakh Eighty Four Thousand Six Hundred only) is being placed as final installment at the disposal of PWD for carrying out above said work. Further the expenditure on the project till its completion will remain restricted to the approved outlay.
