Subject:- Grant-In-Aid to Delhi Brotherhood Society for running the Old Age Home at Lampur for the Senior Citizens under the Scheme of Welfare Programme for Old Age Persons, Major head "223502104710031- grant-In-Aid" for the year 2014-15, 2015-16 and 2016-17.
Sir,

I am directed to convey the sanction of Finance, Department of Social Welfare, GNCT of Delhi in favor of Delhi Brotherhood Society, NGO for incurring an expenditure for payment of remaining amount of Rs. 9,51,180/- (Nine lakh, Fifty One Thousand One Hundred Eighty Rupees Only) out of the total sanctioned amount of Rs. 39,51,180/- (Thirty Nine Lakh, Fifty One Thousand, One Hundred Eighty Rupees Only) to Delhi Brotherhood Society (DBS) NGO for running Old Age Home at Lampur for the period 2014-15, 2015-16 and 2016-17 @ 50% as approved by the Budget and grant-In-Aid Committee in its meeting dated 09.02.2.2018.

Out of sanctioned amount of Rs. 39,51,180/- an amount of Rs. 30,00,000/- (Rupees Thirty Lakh Only) was already released as 1st installment under the Plan Scheme of Welfare Programme for Old Age Persons, Major Head "223502104710031- Grant-In-Aid" to Delhi Brotherhood Society, NGO in the Financial Year 2018-19 vide sanction letter no.F.No.4A(859)/DSW/LC/HC/2015/12648-12660 dated.11-06-2018.

The Delhi Brotherhood Society, NGO will adhere to the following strictly:-

1. The above recurring grant sanctioned for the purpose of running Old Age Home located at Lampur, Delhi-40, as the terms and conditions of Agreement and Subject to observation of codal formalities and other conditions as laid down in the agreement.
2. Expenditure out of GIA shall be incurred only on the purchase of goods/services, purchase/acquisition of which is necessary and in public interest.
3. Expenditure will be incurred only for the purpose for which GIA has been sanctioned and for targets, which have been assigned to the grantee institution by the administrative Department.
4. If the Government of NCT of Delhi is of the observation that the recurring grant sanctioned / released is not being used for the approved purpose or some amount of the same is found unutilized during the current financial year, the Govt. of NCT of Delhi can stop release for further grant and can recover all or partial amount of the recurring grant through enforcement or as land revenue.
5. The expenditure on account of release of the above referred amount of Grant-In-Aid will be debited under the Plan Scheme of welfare programme for Old Age Persons, Major Head "22350210471" of Current Financial Year 2019-2020.
6. The grantee institution shall follow all codal formalities as per GFR, all other provisions and instructions issued by the govt. from time to time and contravention thereof shall render the GIA liable to the world.
7. The grantee institution shall not do any act or undertake any activity which entails additional financial liability for the government without the approval of administrative department and Finance/Planning department.
8. Rules and guidelines issued on the subject time to time should also be adhered to.
9. The organization shall timely submit the Utilization Certificate to the Department duly signed by the Executive Head and certified by the Chartered Accountant in Form 19A GFR.
10. The Organization shall adhere to all the provisions contained in the MOU duly signed by both the parties.
