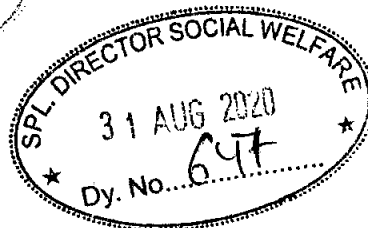
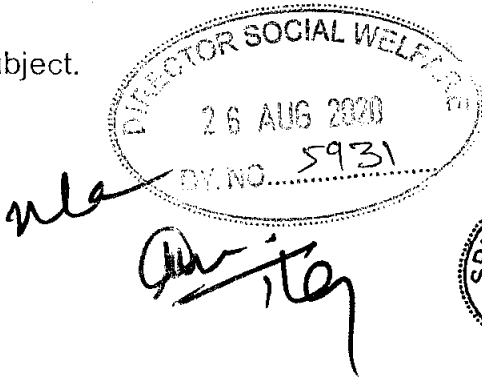
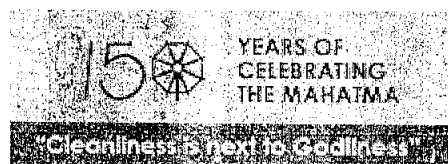

The Last (29<sup>th</sup>) meeting of the Northern Zonal Council was held on September 20, 2019 at Chandigarh under the Chairmanship of the Hon'ble Union Home Minister. Before steps are initiated to convene the next meeting of the Northern Zonal Council, it is necessary that sufficient number of issues having inter-State/Centre State ramifications are received from the member States/Central Ministries/Departments for inclusion in the agenda.

2. I would, therefore, request that the State Government may identify and sponsor important issues that need to be placed before the northern Zonal Council. Each item proposed for inclusion in the agenda may be accompanied by an Explanatory Memorandum both in hard & soft copies (e-mail: [ak.shrivastwa@nic.in](mailto:ak.shrivastwa@nic.in)) indicating:

- Detailed background note of the issue including inter-State and Centre-State ramification;
- Efforts made by the Central Ministry/Department to resolve the same;
- Specific points on which the Council is being approached.

3. The identified items will be scrutinized by the Standing Committee of the Northern Zonal Council, before they are placed for discussion in the next meeting of the Northern Zonal Council.

4. I shall be grateful if copies of the Explanatory Memoranda of items sponsored by the State Government are also sent simultaneously to the Central Ministries/member States in the zone requesting them to forward their comments to us directly, at an early date.
