Record of Discussions

Implementation of Flagship/Development/Welfare Schemes in UTs

• 11:30 am, 28th August, 2020; MHA, North Block, New Delhi

A meeting was held under the chairmanship of Additional Secretary (UT) [AS(UT)] to review the implementation of Flagship/development/welfare schemes in UTs of Andaman & Nicobar Islands (ANI), Chandigarh (CHD), Dadra & Nagar Haveli and Daman & Diu (DNH&DD), Delhi (DEL), Lakshadweep (LKD) and Puducherry (PUD) via video conference on 28th August, 2020 in the Ministry of Home Affairs (MHA), North Block, New Delhi. The list of participants is at **Annexure**.

2. At the outset, AS(UT) welcomed the participants, and set the agenda for the meeting. The following key observations emerged from the discussion:

A. SC Pre-Matric Scholarship Scheme | Ministry of Social Justice & Empowerment (MoSJE)

i. **UTs - ANI** and **LKD** do not have any SC population; hence, they are not covered under the scheme. **DNH&DD** has not received funds/response from the Ministry, despite having sent proposals every year. For **DEL**, there is a need to reconcile the performance figures. The UT has, in fact, exceeded its targets. **PUD** has identified the beneficiaries and has sought approvals for the same from the Ministry. Further, PUD is working towards enhancing the number of beneficiaries under the scheme.

B. SC Post-Matric Scholarship Scheme | MoSJE

i. **UTs - ANI** and **LKD** do not have any SC population; hence, they are not covered under the scheme. For **CHD**, special condition has been laid down in the scheme guidelines, to the effect that GoI would only provide funds to the UT, in case the total expenditure is above Rs. 6 crore. Since the requirement of the UT under the scheme has been less than Rs. 6 crore, CHD has been funding the scheme from its own budget. **DNH&DD** has sent proposals, but has not received any funds/response from the Ministry since 2017-18. Figures

for DNH and DD also need to be clubbed, given the merger of the UTs. **DEL** has exhausted its funds, and is open for more allocation.

C. OBC Pre-Matric | MoSJE

- i. **UTs** - Funds for **ANI** have not been released for 2019-20, despite a proposal being sent to MoSJE. The allocation for 2019-20 to be revalidated in view of enhanced fund requirement in current FY. For **DNH&DD**, funds for 2019-20 have not been received for DNH. For DD, Rs. 11 lakh have been released by MoSJE, against the demand of Rs. 74 lakh. Figures for DNH and DD also need to be clubbed, given the merger of the UTs. For **PUD**, a review exercise of the total number of beneficiaries under the scheme is currently ongoing in the UT. **DEL** has exhausted the funds allocated in the previous years and has sent a request for funds to be released in the current year.

D. OBC Post-Matric | MoSJE

- i. **UTs** - For **ANI**, the allocation for 2019-20 to be revalidated by MoSJE. Further, funds released by the Ministry is less than the amount requested by ANI. For **DNH&DD**, a proposal from DNH shall be sent to MoSJE this year. For DD, no funds released to the UT for FY 2017-18 and 2019-20. Figures for DNH and DD also need to be clubbed, given the merger of the UTs. **PUD** stated that the UT will review the existing list of beneficiaries, and try to increase the beneficiaries under the scheme.

E. Dr Ambedkar EBC Post-Matric | MoSJE

- i. **UTs** - **ANI** stated that the scheme was introduced in the UT in 2019-20. However, no funds have been received from MoSJE, despite proposals having been sent. For **DD**, proposal for release of Rs. 0.2 lakh for 11 beneficiaries has been sent to MoSJE. However, funds have not been released so far. For **DNH**, a proposal will be sent to MoSJE this year. Figures for DNH and DD also need to be clubbed, given the merger of the UTs. **CHD** stated that funds have not been received for 2018-19 and 2019-20 under the scheme. **PUD** also stated that a proposal will be sent under the scheme. **LKD** has written to MoSJE to dovetail the UT scheme with the Central Scheme.

F. Free Coaching for SC & OBC Students | MoSJE

- i. **UTs** – **ANI** stated that no coaching institute has expressed interest in this Scheme. There is no SC and OBC population in **LKD**. **DNH&DD** stated that they will register coaching institutes/centres in the current FY and send the proposal to MoSJE. **CHD** stated that no funds have been released by MoSJE in 2019-20 and 2020-21 despite proposals containing names of eligible institutions being sent to MoSJE. **PUD** stated that presently, most empanelled institutions under the scheme are situated in Chennai. But, a proposal for empanelment of institutions within PUD has been sent to MoSJE, and the decision of MoSJE is awaited.

G. Deendayal Viklang Punarvas Yojana | MoSJE

i. **Department of Empowerment of Persons with Disabilities, MoSJE** stated that no UTs are availing of the scheme, except DEL and PUD. The Ministry is willing to release funds to UTs, as soon as the UTs send the proposals.

ii. **UTs** – **ANI** stated that no NGO has come forward to avail of the scheme. The UT has also requested MoSJE to transfer the funds directly to the Department, which has been denied by the Ministry, since it is an NGO-based scheme. The UT is encouraging more NGOs to avail of the scheme. **CHD** stated that it has identified NGOs and will ensure that the proposal is sent to the Ministry for implementation of the scheme in the UT. **DNH&DD** stated that UT will be reworking the proposal sent to MoSJE in 2019-20, based on the feedback received from the Ministry. **DEL** stated that shortlisting of NGOs is under way, after which a proposal will be sent to MoSJE. Further, data needs to be reconciled with MoSJE. **LKD** stated that the UT will be sending proposal for 2 shortlisted NGOs to MoSJE.

H. Rehabilitation of Manual Scavengers | MoSJE

- i. No UT has reported the existence of manual scavengers.

I. Rashtriya Vayoshri Yojana | MoSJE

- i. **UTs** – **ANI** stated that presently, camps are being held under the Assistance to Disabled Persons for Purchase/Fitting of Aids and

Appliances (ADIP) Scheme. **CHD** stated that the UT is covering the beneficiaries under a different scheme. The UT will also be sending a proposal to the Ministry. **DNH&DD** stated that the UT plans to implement the scheme henceforth. UT has written to MoSJE, requesting it to consider SECC data, instead of BPL data. **DEL** stated that the UT will organise more camps with ALIMCO to increase applicants.

J. Dr. Ambedkar Medical Aid Scheme | MoSJE

i. **UTs** - **DNH&DD** stated that the UT plans to implement the scheme henceforth and will send proposal. **ANI** stated that presently, expenditure is being borne by UT from its own funds and they will try to dovetail their scheme with the Central Scheme. **DEL** stated that the scheme is not popular among people as a similar scheme with enhanced assistance is being implemented by the Government of Delhi.

K. Assistance to Disabled Persons for Purchase/Fitting of Aids and Appliances (ADIP) | MoSJE

- i. **Department of Empowerment of Persons with Disabilities, MoSJE** requested the UTs to send proposals to MoSJE through the online portal. It was also stated that Funds cannot be released under the scheme for past years, as they lapse each year.
- i. **UTs** - **CHD** highlighted the need to reconcile the performance figures with MoSJE. **DNH&DD** stated that no funds have been released for the years 2017-18 and 2018-19. **DEL** stated that a proposal will be sent by next week.

L. Scholarship Scheme | MoSJE

- i. **UTs** - **ANI** stated that the UT will create awareness to encourage students to avail the scheme. **DNH&DD** stated that the local UT scheme is being phased out, and the UT would implement this scheme as it offers more benefits.

M. SAUBHAGYA Scheme | Ministry of Power

- i. Except DEL, all UTs have reported 100% household electrification.

N. UJALA Scheme | Ministry of Power

- i. The performance of the scheme in all UTs is satisfactory.

Key Observations/Action Points:

3. AS(UT) concluded the meeting with the following observations/remarks:
 - i. MoSJE to release funds due to the UTs under respective schemes, as highlighted by the UTs in the meeting, at the earliest.
 - ii. MoSJE to note that data for DNH and DD be merged, and one allocation be made to the UT henceforth, in view of the merger of the UTs.
 - iii. For ANI, the allocation for 2019-20 under the OBC Pre-Matric and Post-Matric Scheme to be revalidated for utilisation in current FY.
 - iv. MoSJE to take steps to empanel institutions in PUD under the Free Coaching for SC/OBC Students Scheme at the earliest.
 - v. ANI to examine ways to dovetail its local scheme with Dr. Ambedkar Medical Aid Scheme.

The meeting ended with a vote of thanks to the Chair.
