
Following decisions were taken during the meeting:-


1. Those organizations who have not submitted their UC of last F.Y, will not be considered for GIA.
2. It was decided that only those organizations who have submitted their UC with complete details of balance sheet will be placed before next committee meeting.
3. Committee directed that one more point in Inspection report Performa should be added mentioning whether the said organization is in a need of non – recurring grant of Rs. 75,000/- and the inspection report should mention clearly what items/assets the NGO actually requires.
4. The details of GIA case decided by the committee are as under.


