S.No.	Period	Remuneration payable in compliance of Hon'ble CAT's order
1.	24.07.2014 to 15.08.2016	Minimum of the Pay Band + Grade Pay + DA of the respective post. This rate shall remain same till the expiry of the contract period. However, such consolidated remuneration can be revised by adding revised DA at each occasion of fresh contract.
2.	16.08.2016 to till date	Minimum of pay of the first level of the pay matrix applicable to the respective post + DA. This rate shall remain same till the expiry of the contract period. However, such consolidated remuneration can be revised by adding revised DA at each occasion of fresh contract.

The above fixation of remuneration shall be subject to verification by audit and in case of any overpayment, the same will be recovered from the remuneration of the employee..
