There are total 112 Recreation Centre's with their status till date , out of 112 RC's, 108 are running for GIA During the F.Y 2019-20 and rest of the 4 cases were closed on the basis of complaint, adverse inspection and blacklisted by Ministry.

Department of Social Welfare has invited the application from various organization/NGO for opening up of new recreation centers. In this regard, total 135 applications have been received. After Scrutiny, 37 applications were found eligible by the committee and 98 were found not eligible. The applicants may be informed through website.
