## The Preamble of Indian Constitution

WE, THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC and to secure to all its citizens: JUSTICE, social, economic and political; LIBERTY of thought, expression, belief, faith and worship; EQUALITY of status and opportunity; and to promote among FRATERNITY assuring the dignity of the individual and the unity and integrity of the Nation

In Our Constituent Assembly on 4th day of November, 1949, do hereby Adopted and Enacted This Constitution
