Subject: - Regarding exams conducted by GBPIT in the month of July-August, 2021.

With reference to the Exams conducted in the month of July-August, 2021 by GBPIT, it has been examined and the following observations are made by the BTE:-

- 1. GBPIT has conducted the exam of lateral entry students of 2<sup>nd</sup> semester for year 2020 in the month of July/August-2021, while as per BTE circular dated 27/09/2021, it should have been conducted in the month of October-2021. Now, it will have to be conducted in the month of Dec 2021 and also submit the award sheets online as well as hard copy to the BTE latest by 31.12.2021 positively.
- 2. GBPIT has conducted the exam of lateral entry students of 1st semester for year 2020 in the month of July/August-2021, which is not in any order issued by BTE. Now, it will be conducted in future alongwith exam of 1<sup>st</sup> semester w.e.f. 22/03/2022(as per academic calendar).
- 3. GBPIT has conducted the exam of some left out students of back/compartment exam of even/odd semester for the year 2014, 2015 & 2016 in the month of July/August-2021, which should have been conducted in the month of Jan.-2021 as per circular dated 04/12/2020. The examinations conducted by the GBPIT in the month of July/August-2021 were not in order as per the orders/ instructions issued by BTE.
- 4. GBPIT has taken undertaking from all the students that in case of BTE does not endorse this exam or cancels it for any reason, I shall not have any direct or indirect claim or hold BTE/Institute responsible for the same. As per BTE norms, there is no provision of such kind of undertaking taken from the students.
- 5. It is also observed that some ineligible students have also allowed to appear in the examination conducted in the month of July-August, 2021.

In view of the above mentioned observations, examinations conducted by GBPIT in the month of July-August, 2021 have not been considered by the competent authority and the same is quashed. So, therefore, You are directed to follow the guidelines/ instructions/orders issued by Competent Authority time to time and communicate the eligible students accordingly well in time along with wide publicity to appear in the forthcoming examinations.
