

The Head of office concerned is requested to ensure, before granting the Financial up gradation under the Modified Assured Career Progression Scheme to Fire operators/CRA/Safai karamchari that 10 years of regular service of the officials does not include the period of service rendered in State Government /Statuary Body/ Autonomous Body/ Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial up gradation under MACP Scheme (Point NO.10 of DoPT Om NO.35034/3/2008-Estt(D) Dated 19.05.2009).
