CIRCULAR

WHEREAS, A final seniority list of UDCs of DJB promoted in Delhi Jal Board w.e.f. 01/01/2007 to 31/12/2017 was circulated by the department vide No.F.DJB/AC(D)/Sen./Sr. Assistant/2018-19/42389 dt:05-08-2019 .

AND WHEREAS, Office Order no. 97 (Min) dt: 27.05.2020 was issued by this office as per direction of Hon'ble CAT in OA no. 3578/2016 for granting benefits of notional appointment, notional pay fixation, notional seniority, Old Pension Scheme and transfer of NPS contribution to GPF to 17 employees (LDCs).

AND WHEREAS, the above 17 candidates mentioned in O.O no. 97 (Min.) dt. 27-05-2020 were given appointment on notional basis from the date the first General Category candidate has joined duty alongwith all the consequential benefits of seniority and pay fixation on notional basis.

AND WHEREAS, a Final revised seniority list in respect of Jr. Assistants appointed in DJB on regular basis w.e.f. 01/05/2003 to 31/12/2007 was circulated on 14.08.2020.

AND WHEREAS, subsequent to the changes done in the date of appointment and placement of these 17 (Seventeen) LDCs/Junior Assistants under SC/ST/OBC Categories in the above mentioned Seniority List, a review DPC was held on 07.01.2021 to review AC(D)'s O.O. No-90 dt. 05.03.2014 & O.O. No-102 (Min.) Dt. 21.05.2015 therefore changing the placement of few UDCs (Senior Assistants) in the seniority list vide AC(D)'s OO No-21 (Min.) dt. 05.02.2021.
