**Subject: Clarifications regarding Levy of Infrastructure Charges.**

In accordance with Board's directions vide Resolution No.1061 dated 04-02-2021, clarification vide No.DJB/DOR/IFC/10/2021/523 to 637 dated 22-01-2021 is modified for Re-opening of Water/ Sewer Connections as under :

S.No.	Query	Modified Clarifications
4.	Whether Infrastructure Charges is payable at the time of re-opening of existing connection?	Infrastructure Charges will be payable on re-opening of existing connection on properties on plot size above 200 Sqm. in case of reconstruction after demolition of existing building.
8.	What will happen, existing building having one water connection (Cut-off) is demolished & reconstructed with four storey (area > 200 sqm) and applies for reopening of existing water connection at Ground Floor & three new connection for 1 <sup>st</sup> , 2 <sup>nd</sup> and 3 <sup>rd</sup> Floor?	Infrastructure Charges will be payable on re-opening of existing cut-off connection in cases of re- construction after demolition of existing building as well as on each additional connection on building of plot size above 200 Sqm.,

2. Infrastructure Charges is paid only once for the particular connection on the same built-up area. In case Infrastructure Charges has been paid at the prevailing rate for the same property of same or more built up area, then Infrastructure Charges at revised rate for such built up area will not be leviable on re-opening of connection. However, for any addition in the built-up area, Infrastructure Charges will be payable.

3. The clarification is issued for implementation with immediate effect and old cases where connection has been released and they are fully paid, such cases will not be re-opened.

4. This issues with the approval of Competent Authority.
