C I R C U L A R

Subject: Clarifications regarding Levy of Infrastructure Charges.

At the time of examining water/sewer connection application, request in the case of one Co-operative Group Housing Society of Dwarka, it has been observed that society has paid infrastructure charges of water and sewer at the time of approval of schemes in 2013. Society has applied connection after completion of construction in 2020. In the meantime, Delhi Jal Board has revised rate of infrastructure charges vide Circular No.DJB/DOR/Infra. Charges/2020/4957 to 5063 dated 06-10-2020. The difference of infrastructure charges has been raised in the new connection bill of the society. The case has been re-examined and following clarification is issued:-

“Infrastructure Charges will be required to be paid only once at the prevailing rates on the date of approval of water/sewer scheme and revision at the current rate will not be required at the time of sanction of water/sewer connection. However, for any addition in the built-up area over the approved building plan or water/sewer connection scheme, infrastructure charges at the current rate for such additional area will be payable”.

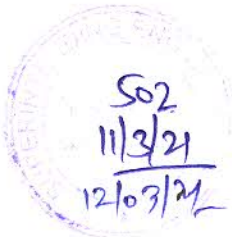
