CIRCULAR

Subject: Revised rates of Dearness Allowance to Central Government employees-
w.e.f. 01.07.2021

Government of India, Ministry of Finance, Department of Expenditure vide O.M. No. 1/1/2020-E-II (B) dated 20.07.2021 (Copy enclosed) have decided to revise the rates of Dearness Allowance from the existing rate of 17% to 28% of the basic pay, payable to the Central Government Employees with effect from 01.07.2021. Consequently, Dearness Allowance from 01.07.2021 would be payable at the rate of 28% of basic pay.

In pursuance of orders of Chief Executive Officer (DJB) dated 03.08.2021, the provisions as contained in the above O.M. are applicable mutatis-mutandis to the employees of the Delhi Jal Board from the same date and on the same terms and conditions.

All the DDOs are requested to ensure that the enhancement of Dearness Allowance is drawn and disbursed as per above orders.
