CIRCULAR

Subject: Policy for supply of treated effluent to the RWAs/consumers for horticulture and other usages.

Delhi Jal Board vide Resolution no. 1148, Item No T-350 has resolved to approve the revised policy for the supply of treated effluent to all the categories including RWAs, Schools & Colleges, Hospitals and other willing consumers etc., for horticulture and other usages etc., on specified terms and conditions. The following has been approved by the Board:

1. The existing rate of Rs.7/ KL shall continue to be applicable for supply of treated effluent to all the agencies /consumers who lift the treated effluent from the filling points of Delhi Jal Board at its STPs or from already laid DJB infrastructure
2. Rs.4/KL shall be charged from the consumers who agree to lay the conveyance system/infrastructure from DJB source/facility upto their premises and also bear the cost of O&M of the conveyance system /infrastructure laid by them. In case any consumer wants to get the conveyance system/infrastructure laid by Delhi Jal Board upto their premises, such works shall be got executed by DJB as a deposit work on their behalf. However, after the execution of the capital work, the conveyance system/infrastructure shall be handed over to the consumer/agency. The rate of supply of treated effluent in such cases will be Rs.4/KL.
3. The treated effluent shall be supplied for irrigation purposes, ground water recharge and recharging of water bodies free of cost. However, the infrastructure shall be laid and maintained by the consumer /agency or will be got created by DJB as a deposit work on their behalf, which will be transferred to the user agencies for O&M after installation.
4. Delhi Jal Board under exceptional cases shall lay and maintain the treated effluent line for supply of treated effluent to the RWAs, School & Colleges, Hospitals and other willing consumers etc., for horticulture and other usages etc., under proper MOU @ Rs.25/KL subject to technical feasibility and availability of funds. Model Draft MOU is enclosed.
