CIRCULAR

Subject: Clarifications regarding Levy of Infrastructure Charges.

Clarifications for individual buildings provided in under Serial No. 14 of the Circular remain the same (copy annexed). However, in other cases levy of IFC for stilt and Basement is clarified as under: -

“Infrastructure Charge is leviable for stilt and basement in building pertaining to CGHS/Residential buildings like hostels, dormitories/Institutional/Commercial/Religious place of worship, Cremation/Burial Ground etc., for parking/Commercial/Service area/residential and other usage as mentioned in the applications/drawings. In cases, usage of stilts and basements has not been specified in the application/drawings. Then basements and stilts areas are considered for parking usages and IFC will continued to be levied accordingly”.

2. The clarification is issued for implementation with immediate effect and old cases where connection has been released and they are fully paid, such cases will not be re-opened.
3. This issues with the approval of Competent Authority.
4. This Circular is issued for strict compliance by all concerned.
