**CIRCULAR**

**Subject:- Provisional Seniority List of Assistant Security Officers promoted during the period from 09-05-2014 to till date.**

2. The objections received, if any, are required to be **verified by the DDOs concerned from the service records**, in case of any discrepancy regarding missing of name/ qualifications/Category i.e. UR/ST/ST/OBC/PwDs, date of appointment etc. the same must be pointed out within the prescribed period.
3. The case of such employees who have already been promoted/ transferred/ resigned/ terminated/dismissed or died from the office of DDOs concerned must be pointed out along with certified copy of relevant orders so that necessary action could be taken for correction in the seniority list.
4. The objections of the individual **must reach this office within 15 days** from the issue of this circular through proper channel duly verified by the DDO concerned from the service book and personal file of the individuals. **The objections received directly, will not be entertained.**

All the DDOs are requested to give it wide publicity amongst the concerned employees and ensure compliance of above by the fixed date and time. If no information is received within the prescribed period, final seniority will be circulated and no further objection will be considered/entertained thereafter.
