### Circular

**Subject: Empanelment of DJB registered Contractor under Rate Contract System (RCS) for awarding Maintenance Works in Water Supply and Sewerage System up to Rs. 10 Lakh in Delhi Jal Board for the FY 2021-22.**

DJB vide circular dated 08/04/2021, has empanelled the Contractors under Rate Contract System (RCS) for awarding Maintenance Works in Water Supply and Sewerage System up to Rs. 10 Lakh in Delhi Jal Board for the FY 2021-22. Recently restructuring has been done in DJB and the maintenance circles are increased from 8 to 11. Further it has been decided by the competent authority to divide the emergent and repetitive nature of civil works in the categories mentioned below and take consent from the contractors already registered under RCS :-

- (i) Making Trial Bores/Boring and Re-boring of Tube-wells.
- (ii) Repair of bursts in the water lines.
- (iii) Water Lines related works
- (iv) Sewer lines related works

In View of above existing contractor already registered in old SE Maintenance circles under RCS, is hereby directed to submit their consent for same nos of new ACE (M) circles as per their existing no of empanelled SE (Maintenance) circles and select categories of work as mentioned above. The list of new maintenance circles is attached as annexure 'A'. The option is to be submitted in application form given overleaf **up to 30 November, 2021** in the office of undersigned. The contractor has to mention the name of ACE (M) circle and code for the category of work for each circle in which he seek to get empanelled. No documents are required with this application.

It is mandatory for all contractors already empanelled under RCS to submit the options. In case of failure; the name of contractor/agency will be removed from the RCS panel list. All ACEs (M) are requested to give wide publicity of this circular among contractors working under their circle.
