Subject: Empanelment of DJB registered Contractor under Rate Contract System (RCS) for awarding Maintenance Works in Water Supply and Sewerage System up to Rs. 10 Lakh in Delhi Jal Board for the FY 2021-22.

This is in continuation of this office circular No. DJB/CE (Dr) Pr-I/F-11/2021/518 dated 08/04/2021, wherein DJB had empanelled the Contractors under Rate Contract System (RCS) for awarding Maintenance Works in Water Supply and Sewerage System up to Rs. 10 Lakh in Delhi Jal Board for the FY 2021-22. Empanelment was done SE (Civil) Maintenance Circle wise.

Further, in compliance of 'Minutes of the Meeting' issued by OSD (Water) vide letter no. Secy.to Chairperson-DJB/2021/782-795 dated 28/10/2021; consent of the contractors already registered in old SE's Maintenance circles under Rate Contract System (RCS) have been obtained in consonance to the re-structured maintenance circles/zones in the department for emergent & repetitive nature of civil works in the following categories:

- I. TW: Making Trial Bores/Boring and Re-boring of Tube-wells.
- II. RW: Repair of bursts in the water lines.
- III. WL : Water Lines related works
- IV. SL : Sewer lines related works

As per consent received from 392 contractors/firms for various categories no. of contractors/firms empanelled under Rate Contract System, ACE (M) wise are as follow:

- The empanelment of contractors is subject to fulfilling the criteria & deposition of processing fee/performance guarantee as per EOI terms and conditions. The name of defaulter contractor/agencies, if any, will be removed from the empanelled list.
- The ACE-Circle/Zone wise list of Contractors for empanelment under RCS system for respective 11-circles/zones are enclosed with this circular
- Validity of empanelment under Rate Contract System is up to 31.03.2022 or upto the validity date of registration of the firm/agencies in DJB.

All the codal formalities and extant instructions in this regard, strict quality control and due diligence must be exercised to assure financial prudence during implementation of Rate Contract System (RCS) by respective circles/zones.


