Madam/Sir,

It is a matter of great concern that around 1.50 lakhs people lose their lives every year in India due to road accidents and many more suffer debilitating injuries. This causes immense economic hardship and emotional trauma to the affected families. There is an urgent need to make our roads safer because the loss of lives and limbs cannot be accepted as an inevitable consequence of mobility. The Central and the State Governments have been implementing various measures to make our roads safer. But the magnitude and gravity of the problem is such that these steps alone will not suffice. There is a need for society at large to take cognizance of the issue and make road safety awareness a mass movement.

2. To sensitise all the stakeholders on safer road mobility, the Central and State Governments observe "Road Safety Week" every year, wherein various activities are taken up for advocacy and promotion.

3. This time, instead of Road Safety Week a month long program National Road Safety Month will be observed from 18<sup>th</sup> January, 2021 to 17<sup>th</sup> February, 2021. The theme of this year is, "Sadak Suraksha- Jeevan Raksha". The Details of Road Safety Activities scheduled to be organized during the National Road Safety Month are Attached herewith for ready reference (Annexure-I). The Month will be inaugurated on 18<sup>th</sup> January, 2021 followed by day-wise different activities. It is proposed to initiate a pre-campaign on Road Safety at State and District level during 20<sup>th</sup> January, 2021 to 25<sup>th</sup> January, 2021 as a build up to the other events.


