CIRCULAR

Subject: Online Admission Process under EWS/DG and Children with Disabilities Category at Entry Level of the Private Unaided Recognized Schools of Delhi for the Ensuing Academic Session 2021-22,

As per Section 12(1)(c) of RTE Act, 2009, all Private Unaided Recognized Schools are under obligation to admit, at the entry level classes, to the extent of at least 25% of the strength of that class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.

Directorate of Education Govt. of NCT of Delhi had initiated online system for admission under EWS/DG category from the academic session 2016-17 and continued the same for the session 2017-18, 2018-19, 2019-20, & 2020-21 in respect of the Private Unaided Recognized Schools under the provisions of Delhi School Education Act and Rules, 1973 (from session 2018-19, the school recognized under RTE Act 2009 have also included). Now, the department has to initiate the online admission process of EWS/DG category candidates at entry level class(es) (Pre-school/Nursery, Pre- primary/KG and class-I as the case may be) of Private Unaided Recognized Schools of Delhi for the ensuing academic session 2021-22.

However, to maintain the uniformity in EWS/DG category admission process at entry level class(es) in respect of all Private Unaided Recognized Schools of Delhi (except the minorities schools), it was decided by the Competent Authority to conduct the online admission process in respect of all the Private Unaided Recognized Schools of Delhi including the schools recognized under the provisions of RTE Act, 2009 & by MCDs for the academic session 2021-22 also.

For this, the list of Private Unaided Recognized Schools which will participate in the online admission process is required to be updated with correct GPS coordinates, at the first instance. Therefore, all District DDE's are hereby directed:-

- To provide the updated list of all Private Unaided Recognized Schools of Delhi (as per the Proforma enclosed).
- To provide the correct GPS coordinates of all the schools as per jurisdiction and also provide the GPS coordinates of the new schools to be added and school(s) shifted to new premises, if any.
- To provide the information regarding EWS/DG category seats at the entry level class(es) (Pre- school/Nursery, Pre-primary/KG & class-I as the case may be) in respect of all



Private Unaided Recognized Schools of Delhi. The District DDEs must ensure that the number of EWS/DG category seats disclosed by the schools in their entry level class(es) shall not be less than the highest number of seats in the entry level class in the previous four academic years in accordance with the notification dated 28.02.2012

All District DDE'S are hereby directed to get the above exercise completed by 15th February 2021 and forward the updated list of schools along with GPS Coordinates and number of seats in the enclosed Proforma to Private School Branch, DoE, Old Secretariat, New Delhi latest by 15th February 2021 in hard copy as well as soft copy (in excel format), so that further necessary action can be taken for starting online admission process for the next academic session i.e. 2021-22, well in time.
