CIRCULAR

Sub: - Recommendation/Nomination for Delhi Bravery Awards to be announced on the occasion of the Republic Day, 2022.

Delhi Government has constituted Delhi Bravery Awards to recognize and honour people who have displayed exemplary courage, presence of mind and bravery in the face of acute danger and who have performed deeds of outstanding bravery and selfless service risking their lives to protect others. The awards will be given for showing courage and promptitude under circumstances to great danger to the life and bodily injury of the rescuer in saving life of those in crisis from drowning, fire, various disasters and other dangerous situations. The act of bravery would be recognized and honoured in government function of the Republic Day, 2022.

The Awards are given in a single category and the awardees/N.o.K will receive a medal, a citation and cash award for Rs. 2,00,000/- (Rupees Two Lakh only). The number of awards will be capped at 10 Nos. (Ten) per year. Persons in all walks of life are eligible for these awards.

For the Year 2022, the recommendation for Delhi Bravery Award will be considered only if the abovesaid act of bravery had already been performed **between 1st September, 2019 to 31st August, 2021.**

The eligible applicants/their legal heirs/any other person on behalf of applicant can deposit their applications/recommendations to their respective Deputy Commissioner (Revenue), Govt. of NCT of Delhi **latest by 15th September 2021.** The circular and prescribed *pro forma* can be downloaded from www.delhi.gov.in/departments.html>Homedepartment (For ready reference, the letter bearing No.F.1/79/2016/HG/1835 dated 10/08/2021 of Dy. Secretary (Home), Govt. of NCT of Delhi, is annexed).

Delhi Government has constituted Delhi Bravery Awards to recognize and honour people who have displayed exemplary courage, presence of mind and bravery in the face of acute danger and who have performed deeds of outstanding bravery and selfless service risking their lives to protect others. The purpose behind framing this award scheme is to encourage other people to come forward to help others. The awards will be given for showing courage and promptitude under circumstances to great danger to the life and bodily injury of the rescuer in saving life of those in crisis from drowning, fire, various disasters and other dangerous situations. The acts of bravery would be recognised and honoured in government function of Republic Day 2022.

The awards are given in a single category and the awardee/N.o.K will receive a medal, a citation and cash awards for Rs.2 Lakh (Rupees Two Lakhs). The number of awards will be capped at 10 (ten) per year. Persons from all walks of life are eligible for these awards.

The recommendations for the awards are to be forwarded in the enclosed proforma (**Annexure-I**). In addition to the bio-data, a detailed citation in narrative form (maximum 250 words), clearly bringing out the sequence-wise details of the incident as well as the specific role/contribution of the person (rescuer) is to be furnished in each case. A character and antecedents verification certificate is also to be furnished in each case in the enclosed proforma (**Annexure-II**). The recommendations for this award are considered by Selection Committee within a period of **two years from the date of performance of the act**. Therefore, for the year **2022**, any recommendation in respect of which the date of performance of the act falls between **1st September 2019 to 31st August 2021** would only be considered. Any recommendation in respect of which the date of performance of the act (occurrence of incident) falls **prior to 1st September, 2019** should not be forwarded to this office.

The eligible applicants/ their legal heirs / any other person on behalf of applicant can deposit their applications / recommendations to their respective Deputy Commissioner (Revenue), Govt. of NCT of Delhi **latest by 15th September 2021**. The circular and prescribed proforma can be downloaded from www.delhi.gov.in/departments.html > Home department.
