

The aforesaid ad-hoc promotion of the officials is subject to the following conditions:-

- I. The ad-hoc promotion is further subject to vigilance clearance in terms of DOPT OM NO. 22011/4/91-Estt.(A) dated 14.09.1992, OM No. 2012/1/99-Estt.(D) dated 25.10.2004 and OM No. 22034/4/2012-Estt.(D) dated 02.11.2012. The Department where the official is working should relieve the official only after ensuring that no disciplinary proceedings are pending or contemplated against the official. In case of pendency of such proceedings, the matter may be reported to this Directorate immediately.
- II. The promotion on ad-hoc basis is effective from the date of assumption of charge of the post of Laboratory Assistant by the official concerned in the school of this Directorate to which he /she has been posted.
- III. The ad-hoc promotion to the post of Laboratory Assistant shall not bestow on the incumbents any claim for regular promotion to the grade.
- IV. The promotion is being made on purely on ad-hoc basis and the ad-hoc promotion will not confer any right for regular promotion.
- V. The service rendered on ad-hoc basis in the Laboratory Assistant would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- VI. The ad-hoc promotion shall not confer any right on the incumbents to continue in the grade indefinitely and may be terminated at any point of the time without giving any reasons thereof.

- IX. The benefit of promotion will be admissible to the above mentioned officials only with effect from the actual date of their joining the post of Laboratory Assistant in this Directorate.
