Sub: Regarding Vaccination of Teachers & Staff of Directorate of Education.

As we all are aware that the country is threatened with the COVID-19 Pandemic, it is necessary to take all effective measures to prevent the spread of the same. The schools under Directorate of Education have been reopened in a phased manner, so it is the prime concern of DoE, GNCT of Delhi that the environment of the schools remains safe with the appropriate implementation of SoPs/measures.

It is imperative that Directorate of Education ensures all the Government Schools Teachers and staffs get vaccinated on immediate basis, therefore, Head of all the Govt. Schools of Directorate of Education were directed to ensure that all teachers & school staff who have not vaccinated should be vaccinated by 15th October, 2021.

Further, Delhi Disaster Management Authority(DDMA) vide Order No.F.02/07/2020/S-1/Pt-1/479 Dated:08/10/2021 has directed as follows:

- i) All Govt. employees working in Departments/Autonomous Bodies/PSUs/Local Bodies/Educational Institutions under Govt. of NCT of Delhi including frontline workers, healthcare workers as well as teachers and other staff working in schools/colleges should get vaccinated(at least first dose) by 15.10.2021 as per prevailing guidelines/protocols prescribed for vaccination by MOH & FW, Govt. of India.
- ii) The aforesaid Govt. employees/frontline workers/healthcare workers/teachers and other staff working in schools/colleges, who do not get vaccinated(at least first dose) by 15.10.2021 shall not be allowed to attend their respective offices/healthcare institutions/educational institutions with effect from 16.10.2021 till they have obtained the first dose vaccination.
- iii) The said period of absence from duty shall be treated as "On Leave" till the administration of the first dose of vaccination.
- iv) The administration of the first dose of vaccination/complete vaccination shall be verified by the concerned HOD/office through Arogya Setu application/certificate of vaccination produced by the concerned employee.

Further, in order to ensure that all the students/teachers/other school staff remain secure and safe, all DDE (District), DDE (Zone) & HoS of Govt. schools of Directorate of Education are directed to:

- 1. Ensure that all teachers & school staff who have not vaccinated till 15th October, 2021 should not be allowed to attend the school as per prevailing guidelines/protocols prescribed for vaccination by MOH & FW, Govt. of India.
- 2. The said period of absence from duty shall be treated as "On Leave" till the administration of the first dose of vaccination.
- 3. The administration of the first dose of vaccination/complete vaccination shall be verified by the concerned HOD/office through Arogya Setu application/certificate of vaccination produced by the concerned employee.

A google tracker link has been devised to capture the status report of vaccination of teachers & staff of DoE. All HOS of Govt./Govt. Aided and Private Unaided recognised schools of DOE are directed to submit the desired information using the below mentioned link latest by 4 PM on 24/10/2021. All RDEs, DDE(District) & DDE(Zone) shall ensure that the desired information is positively submitted by all the schools under their jurisdiction as per the prescribed time schedule.
