CIRCULAR

In continuation to previous circulars issued from this office vide F.No 12(37) NCERT/Acad/SCERT/2021/7612-24 dated 29-10-2021 and F.No. 12(37)NCERT/Acad/SCERT/2021/7792-7802 dated 2-11-2021 regarding NAS,2021, it has been observed that there are some evening shift schools in the list of sampled schools, Hence it is directed that all the sample schools including Evening shift schools selected for survey must remain open on 12th November 2021, and the strength of the sampled grade must be full as far as possible for successful conduct of NAS.

It is hereby directed to all HoS of sample schools of morning and evening shift and concerned officials to ensure the compliance of the following

- 1. Ensure that all sampled schools are functioning for the sampled grade on 12th November 2021 in the morning shift, even if it is the Evening shift School.
- 2. Ensure that no other activities (such as Annual Function, Sports Day, Cultural Event etc.) is fixed on 12th November, 2021.
- 3. All the students of sampled grade (whether class 3, class 5, class 8 or class 10) must be present on the day of survey to ensure the smooth conduct of NAS.
- 4. Time schedule for Survey is as mentioned below:

Grade	Duration	Start Time	End Time
Grade 3 and 5	90 Minutes	10:30 AM	12:00 PM
Grade 8 and 10	120 Minutes	10:30 AM	12:30 PM

- 5. Survey includes Achievement Test (AT) and Pupil Questionnaire (PQ) which are to attempted and filled by the students of the sample batch. Sample batch standard size is 30.
- 6. Concerned subject teacher(s) of the Sampled Section must be present to fill the Teacher Questionnaire (TQ).
- 7. HoS fill up the School Questionnaire (SQ) and provide complete and factual data as sought in the Questionnaire.

**All other instructions will remain same as per previous circulars.
